## ADDENDUM NO. 2

The following items shall take precedence over the drawings and specifications for the above named project and shall become a part of the contract documents. Where any item called for in the specifications, or indicated on the drawings, is not supplemented hereby, the original requirements shall remain in effect. Where any original item is amended, voided, or superseded hereby, the provisions of such item not specifically amended, voided or superseded shall remain in effect.

## <u>General</u>

- 1. Reference the attached Pre-Bid Sign-in Sheet from the non-mandatory Pre-Bid Conference held Tuesday, May 24th, 2016, at 10:00 a.m. at the Strom Thurmond Wellness & Fitness Center - Rotunda.
- 2. Substantial Completion is 45 days from Notice to Proceed.
- 3. Deadline for Questions: Wednesday, May 25<sup>th</sup>, 2016, end of business day. Submit all questions electronically to Kim Bendillo at <u>kbendillo@garvindesigngroup.com</u>.
- 4. Deadline for Addenda: 120 hours prior to closing: Thursday, May 26<sup>th</sup>, 2016, at 2:00 p.m. No further addenda will be issued after this point.
- 5. Bid Closing: Tuesday, May 31, 2016, at 2:00 p.m. at the Strom Thurmond Wellness & Fitness Center, 1000 Blossom Street; Conference Room 201-F.
- 6. One-half inch wide horizontal stainless steel bars at reveals on face of casework are to remain in place. Surfaces within the reveals are not required to receive new plastic laminate.
- 7. Plastic laminate in horizontal plane under upper solid surface transaction top at "Second Floor Main Control Desk" and "Third Floor Reception Desk" may be seamed around stainless steel posts supporting transaction top. Seams to be flush and butted together in clean manner.
- 8. For the painting scope at the "Band Around Rotunda," see attached revised sheet with corrected height of band above finished floor and radius of Rotunda band.
- 9. Clarification of requirements for using a lift to access the high band at the Concourse adjacent to the climbing wall (at the opening in the main floor): The procedure for approval to use a lift will require the contractor to submit the model of lift (must be electric) including the type, weight, dimensions, extension distance, tire specs, etc. to the Owner and architect for review by a structural engineer and the Owner.
- 10. The Owner will provide for the Contractor's use: one man 40' lift and a one man 30' lift. Both will go through a 3' opening. The 40' can only be used on the first or second floor, and the 30' can go on any floor.

11. Additional plastic laminate replacement scope: Replace copper color plastic laminate at the "Second Floor Weight Room Desk," west interior side, on the shelving unit shown in the photograph below (all sides, faces, shelves, etc.) with PL-1.


