- 4. Question: Award Criteria please explain what makes a bidder "responsive" and how this would be used in the evaluation? In other words, does cost and responsiveness make up 50% of the grading criteria for award determination?

5. Question: How and who will evaluate the daily/weekly performance of the client?

Answer: Staff will be given a checklist to be completed each night and turned into a designated spot prior to their exit. Campus Recreation professional staff and Custodial Supervisor will record any deficiencies and deliver them to the onsite manager either via email or in person.

6. Question: Is it required that the gender of the contractor performing the work in the gender based locker room match?






