- Deleted all motorized rigging including the 1st and 2nd Electrics, the Cyc and the projection screen.

- Deleted the motorized rigging catwalk, its handrail and its access ladder.

- Deleted the Electrical equipment and installation necessary for the motorized rigging.

- Substituted dead-hung rigging materials in lieu of the motorized rigging.

- Rigging and Electrical Labor was adjusted for these changes.

- Removed the tracks for the side tab curtains – battens remain.

- Deleted the isolated ground transformer and its wiring including its labor.

- Deleted the lighting console desk with monitor arms. Existing desk may be reused or another school owned table can be used.

- Substituted Tannoy VX5.2 speakers in place of the specified surround speakers.

- Substituted a Danley SM96 in place of the specified center speaker.

- Deleted the Automated Lighting fixtures from the Performance Fixture Package.

- Deleted the door from the Lighting System Equipment Rack.

- Deleted the DMX splitters and ACN Nodes and replaced them with two Pathway Octo Gateways that will be installed in the Lighting System Equipment Rack.

- Moved the Lighting System Equipment Rack to the Dimmer Room.

Contractor should not incur any costs associated with the contract prior to receipt of a contract from the Agency for execution. Contractor should not perform any work prior to (1) delivering to the Agency both certificates of insurance and Performance and Payment Bonds meeting the requirements of the solicitation; and (2) receipt of the Agency's written Notice to Proceed.
