## I. Scope of Solicitation

ACQUIRE SERVICES (January 2006): The purpose of this solicitation is to acquire services complying with the enclosed description and/or specifications and conditions.

MAXIMUM CONTRACT PERIOD — ESTIMATED (January 2006): [September 1, 2017- August 31, 2022] Dates provided are estimates only. Any resulting contract will begin on the date specified in the notice of award. See clause entitled "Term of Contract — Effective Date / Initial Contract Period".

It is the intent of the University of South Carolina to solicit proposals from qualified sources of supply to provide management of the fitness operations of the Gregory Health and Wellness Center (GHWC) at USC Lancaster in accordance with all requirements stated herein.

#### II. Instructions To Offerors - A. General Instructions

DEFINITIONS, CAPITALIZATION, AND HEADINGS (FEB 2015)

# III. Scope of Work / Specifications

USC Lancaster (USCL) seeks established and reputable vendor in the fitness center industry to manage and enhance the fitness operations of the GHWC—a center that serves the community and the USCL campus.

#### THIS CONTRACT WILL BE A REVENUE-GENERATING CONTRACT:

On an annual basis, Contractor will split the revenue generated from its management of the fitness operations of the Gregory Health and Wellness Center with USC Lancaster. The split paid to USC Lancaster by the Contractor will be either the Annual Guarantee for the year of the contract term or the Percentage of Net Revenue for the year of the contract term, whichever is larger.

Net Revenue is the Gross Revenue, including but not limited to, revenue generated from following: membership fees paid by current and new members to the Contractor, fees collected from patrons by the Contractor, any revenue earned from grants awarded to support fitness instruction, and revenue derived directly from the University for use of the fitness operations of the Gregory Health and Wellness Center (GHWC) minus operating costs of the fitness operations of the Gregory Health and Wellness Center (GHWC).

REASON FOR OUTSOURCING: USC Lancaster is looking to outsource the fitness operations of the Gregory Health and Wellness Center in order to broaden the types of activities and programming available for our community and campus members and to appeal to a broader demographic especially young families with children. The University is seeking reputable firms that are able to market, program, and attract a diverse membership which will strengthen health and wellness instruction, activities, and programs for the greater Lancaster area to respond to the solicitation.

Summary of building maintenance: Construction was completed on the Gregory building in 1981, and the Center opened in September of that year. Apart from ad hoc repairs such as new flooring in the lobby, main floor hallway and fitness/workout area (former community room, flooring completed approximately early 2000s), a new roof (mid-1990s) men's shower and steam

room renovations (around 2000) and a few other minor upgrades and refurbishments, the Center has never been renovated in a comprehensive manner.

In fiscal year 2013, the Gregory building was allocated \$400,000 by the state legislature for improvements to the building. That fall the prioritized deferred maintenance list for the building was updated in preparation for using the funding. The first use of the money was to replace the pool deck, paint the natatorium walls, and add a unisex, handicap-accessible changing room, shower, and dressing area in the former and then defunct whirlpool space adjacent to the pool. After coordination with the aquatics staff, the project began in late summer 2014 and the pool reopened around Labor Day. This area was of concern and a priority due to DHEC regulations regarding pool decks and surfaces. Just short of half of the \$400K was spent on this first project.

The second project using the previously allocated \$400K involved renovation of the lobby and membership services office suite. After coordination with the membership services office staff, this project was completed in the summer of 2015. The project updated the look of the lobby area and office areas with new flooring/carpeting, furniture, entry and membership services desk areas, lighting, and paint. After these 2 projects, there is approximately \$10K left from the original \$400K allocated.

In Summer 2015, aquatics director alerted to the fact that the pool pump and filtration system needed repairs or replacement. In early Fall 2015, the process for an emergency project to replace the systems was begun. This was year 20 with the system with a life-span of about 15 years. Funds were approved, project was designed, and the system was replaced in November 2015.

Approximately \$640K was appropriated for the Gregory Health and Wellness Center for FY 17. Using our updated deferred maintenance list for the building, we identified three major projects to target with these funds: replacement of solarium windows in the natatorium area (damaged in 1989 during Hurricane Hugo and in disrepair due to age), replacing the gym and racquetball court floors, and renovation of the men's and women's locker room, dressing, and shower areas. We have requested an expedited authorization of the funds so as to begin these projects somewhat earlier than in previous years. Projects to repairs these areas are on track to begin in late summer 2017.

1) Personnel: Contractor will consider hiring of current non-student and student workers at the GHWC.

This is based roughly on current staffing. These are estimates and may change if firm/organization chooses to change hours of operation or activities/services provided: Pool—aquatics director, and 10-12 trained and certified lifeguards depending on the number of swim lessons and the number of other water activities scheduled. This is based on the lifeguards being USC Lancaster students who have class schedules to attend. Building supervisors, Full-time Center manager and 4-5 part-time building supervisors who cover the facility before and after regular business hours (8:30 to 5:00)

Membership services and check-in; this could be combined into a one-stop area, would need 6-7 part-time individuals and one full-time individual to cover week's worth of operation.

Fitness area attendants: 4-5 part-time. These can also serve as building supervisors at other times.

Maintenance and Custodial: Contractor shall be responsible for the daily maintenance and custodial of the GWHC facility with USCL responsible for major repairs at or in excess of \$15,000. Contractor should consider outsourced daily custodial, day porter, etc.

Certifications: CPR, Certified Pool Operator, ACSM certification (or other such professional organization) for writing member fitness plans

2) Furniture and equipment: Contractor shall supply all furniture, supplies, computers, chemicals, and equipment necessary for operations of the GWHC. However, contractor may consider using the following USC Lancaster furniture and equipment if it wishes to.

The building currently contains the following (all, except computer equipment, can remain after transition of operation):

Office and lobby area furnishings: These include 4-6 desks and desk chairs, 6-8 filing cabinets, 2 couches, 2 chairs, round seating area, 2 end tables which can all stay in the building.

IT and telephone: 10 telephones, 2 analog lines for FAX and credit card terminal, 8 computers, 1 Cisco network switch, 6 printers, wi-fi, entry door control system, limited security cameras (9 cameras) and DVR recording system, bank of 10 television screens in treadmill area. All can stay, but contractor may wish to supply its own computers and software system for membership data.

Fitness area: 10 treadmills, 22 nautilus pieces of equipment, 15 elliptical pieces of equipment

Yoga room: mats

Gymnasium: pickle ball nets, paddles, and balls (two sets), basketballs, 28 spin bikes, elevated walking/running track, retractable bleacher system with seating for about 600, Zumba—Speaker and Projector, 15 Zumba sticks / Dumbbells

3 racquetball courts: various racquetball equipment for check-out

Free weight room: 10 Free Weight Stations with weights at each stations, 40 Dumbbells

# Pool chemicals and supplies:

From Pure Aqua: Accu-tab chlorine tablets, Thiosulfate, calcium hypochlorite granules, calcium chloride, sodium bicarbonate

From Home Depot: Muratic acid, squeegee heads & poles, brushes

From Praxair: CO2

Pool equipment (all can remain after transition of operation):

Additional note: There is an adjacent tennis court area (6 courts and a tennis shack with restrooms) behind the building that is currently open to community use without membership dues. This needs to remain outside of this contract as it is used by a local high school for practice and play. There is a picnic pavilion behind the tennis courts that is to remain outside of this contract as well.

## INDEMNIFICATION AND INSURANCE REQUIREMENTS

Contractor agrees to indemnify and hold the University of South Carolina, their offices and employees harmless and free from loss, damage or expense arising out of claims for bodily injury or property damage as a result of Contractor's or Contractor's employees' acts or omissions in performing operations under this agreement. The University agrees to notify Contractor of any claims for which it seeks indemnity under this agreement in a timely fashion and to cooperate with the Contractor in the investigation, defense and settlement of all such claims. Comprehensive general liability insurance, broad form, written on an occurrence basis, with defense cost provided in excess of the limit of liability, that will protect and defend the Contractor and any subcontractors, their employees or agents performing work covered by this Contract accordingly. The limits of coverage shall, as a minimum, be \$2,000,000 per occurrence / \$2,000,000 aggregate for bodily injury and property damage.

The following coverage parts shall be included: personal injury Group A bodily injury and property damage, Group B personal and advertising injury, and Group C medical payments in the amount of \$5,000; broad form property damage with a minimum of \$500,000 for damage to premises rented by you; and contractual liability. Such policy of insurance shall be issued by a company or companies with at least an "A" Best rating or rating equivalent and qualified to do business in the State of South Carolina. The University shall be named as an additional insured.

Commercial Automobile Liability Insurance providing bodily injury and property damage coverage, covering all owned, non-owned, and hired vehicles used in connection with the activities undertaken under this Contract, with a combined single limit of \$1,000,000 for bodily injury and property damage. The University shall be named as an additional insured.

Workers' Compensation and Employer's Liability Insurance covering each employee engaged in the performance of the work under this Contract, with a limit of liability in accordance with applicable law in the case of Workers Compensation Insurance, and with the following limits of liability in the case of Employer's Liability Insurance:

Umbrella liability coverage of \$5,000,000 per occurrence. The University shall be named as an additional insured.

Contractor assumes all risk of damage to and loss of (by theft or otherwise) any Contractor fixtures, appliances, instruments, clothing or other property of Contractor or Contractor's employees, agents, guests, or other parties contracting with Contractor, as well as employees thereof, and The University is expressly released and discharged from any and all liability for any such loss. Contractor agrees to maintain in force, at all times during the term of this license, on all Contractor fixtures, equipment, personnel, and inventory in the Demised Premises, a policy or policies of insurance with companies licensed to transact business in the State of South Carolina, to the extent of 100% of the insurable replacement value thereof, the proceeds of which will, as long as this license is in effect, be used for the repair or the replacement of the property so insured.

Employee Dishonesty Insurance covering all employees of the Contractor, of a nature designed for fitness center operation, in an amount satisfactory to the University, at the inception of the contract. The insurance policy shall name the University as an additional insured in the event that the dishonesty of a Contractor employee results in a loss of University property.

Business Interruption Insurance covering loss of income and extra expense by the Contractor for the period of one (1) year resulting from interruption of business caused by any covered occurrence.

As necessary, Medical Professional Liability Insurance covering all employees, subcontractors and volunteers of the Contractor involved with hands on patient care in the amount of \$2,000,000 per occurrence / \$2,000,000 aggregate.

All insurance coverages shall be on as occurrence-basis. Claims-made insurance coverages will be acceptable only when occurrence-basis insurance coverages are not attainable, and when approved by the University. Claims-made coverages must include tail coverage for claims presented within thirty-six (36) months of Contract termination.

All insurance shall remain in full force and effect throughout the duration of the Contract. All insurance shall be secured by the Contractor from companies of recognized financial responsibility, licensed to do business in the State of South Carolina.

Failure or inability to secure the required minimum, or fully adequate, insurance by/for the Contractor, any subcontractors, any employees, or agents of either, shall in no way relieve the Contractor of their responsibility for its own acts or the acts of any subcontractors or any employees or agents of either.

The Contractor shall provide certificates evidencing each of the insurance policies to be maintained by each in compliance with the provisions of this RFP and the Contract at the start of the Contract. Each binder and policy required to be obtained and maintained by the RFP and the Contract shall provide that it may not be amended, modified or canceled without a minimum of thirty (30) days' notice to the University. Any changes or alterations affecting the University, its employees or agents must have prior approval, in writing, by the University. Contractor shall provide copies of insurance policies upon request of the University.

# 4) Operating Costs: annual utility costs

Contractor will be responsible for all operating costs associated with its programs, including staffing, program's equipment and a progressive takeover of utilities (electricity, natural gas, water, and sewer). Contractor will maintain a separate budget for the operation of the GHWC and will make its Annual report available to USCL for review when requested.

Utilities are roughly \$130,000 a year. Copies of this year's budget and a copy of the budget for the last 5 years are provided.

A progressive takeover of utility costs for the building would look something like the following:

Year 1: Contractor pay approximately 25% of utilities

Year 2: Contractor pay approximately 25% of utilities

Year 3: Contractor pay approximately 50% of utilities

Year 4: Contractor pay 100% of utilities

Year 5: Contractor pay 100% of utilities

5) Access by USC Lancaster (USCL): number of faculty, staff and students we have, how many classes will be taught and how many rooms should be made available.

USCL retains the right to access to the building for the teaching of academic courses (PEDU) to its students and for use by the Lancers athletics teams; likewise, faculty, staff and students may remain members of the facility free-of-charge.

We teach an average of about 35 PEDU courses per semester, most, if not all, are half semester courses. These courses use spaces in the gym, pool, weight and fitness rooms, etc...There are 65 full-time faculty, about 65 staff members, and in Fall 2016 there were 1174 FTE students enrolled.

6) Other Considerations: number of parking spaces at the GWHC; name change of the building.

Contractor may make minor changes (changing traffic flow, other changes for added/expanded services, etc...) to the physical structure of the building with prior written approval of USCL administration and USC facility services. As the building remains property of the University of South Carolina and the State of South Carolina, USCL will continue to seek capital and deferred maintenance funding for the building areas or building systems through the State of South Carolina General Assembly.

Parking Spaces: (front and back of building) 114 general spaces + 18 handicapped spaces = 132 total. During the contract term, the name of the building can't be changed as it's a state building, but the fitness operation name can change from Gregory Health and Wellness Center to a mutually agreed upon name.

Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the

Government. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court, despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-3]

PUBLICITY (JAN 2006): Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006): Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. Purchase orders may be used to elect any options available under this contract, e.g., quantity, item, delivery date, payment method, but are subject to all terms and conditions of this contract. Purchase orders may be electronic. No particular form is required. An order placed pursuant to the purchasing card provision qualifies as a purchase order. [07-7A065-1]

SURVIVAL OF OBLIGATIONS (JAN 2006): The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. [07-7A075-1]

TAXES (JAN 2006): Any tax the contractor may be required to collect or pay upon the sale, use or delivery of the products shall be paid by the State, and such sums shall be due and payable to the contractor upon acceptance. Any personal property taxes levied after delivery shall be paid by the State. It shall be solely the State's obligation, after payment to contractor, to challenge the applicability of any tax by negotiation with, or action against, the taxing authority. Contractor agrees to refund any tax collected, which is subsequently determined not to be proper and for which a refund has been paid to contractor by the taxing authority. In the event that the

contractor fails to pay, or delays in paying, to any taxing authorities, sums paid by the State to contractor, contractor shall be liable to the State for any loss (such as the assessment of additional interest) caused by virtue of this failure or delay. Taxes based on Contractor's net income or assets shall be the sole responsibility of the contractor. [07-7A080-1]

TERMINATION DUE TO UNAVAILABILITY OF FUNDS (JAN 2006): Payment and performance obligations for succeeding fiscal periods shall be subject to the availability and appropriation of funds therefor. When funds are not appropriated or otherwise made available to support continuation of performance in a subsequent fiscal period, the contract shall be canceled. In the event of a cancellation pursuant to this paragraph, contractor will be reimbursed the resulting unamortized, reasonably incurred, nonrecurring costs. Contractor will not be reimbursed any costs amortized beyond the initial contract term. [07-7A085-1]

THIRD PARTY BENEFICIARY (JAN 2006): This Contract is made solely and specifically among and for the benefit of the parties hereto, and their respective successors and assigns, and no other person will have any rights, interest, or claims hereunder or be entitled to any benefits under or on account of this Contract as a third party beneficiary or otherwise. [07-7A090-1]

WAIVER (JAN 2006): The State does not waive any prior or subsequent breach of the terms of the Contract by making payments on the Contract, by failing to terminate the Contract for lack of performance, or by failing to strictly or promptly insist upon any term of the Contract. Only the Procurement Officer has actual authority to waive any of the State's rights under this Contract. Any waiver must be in writing. [07-7A095-1]

## VII. Terms and Conditions - B. Special

HIPAA LAW: The Contractor agrees that to the extent that some or all of the activities within the scope of this Contract are subject to the Health Insurance Portability Accountability Act of 1996, P.L. 104-91, as amended ("HIPAA"), or its implementing regulations, it will comply with the HIPAA requirements and will execute such agreements and practices as the University of South Carolina may require to ensure compliance. Additional information may be viewed at: <a href="http://www.sa.sc.edu/shs/hipaa">http://www.sa.sc.edu/shs/hipaa</a>

PROTECTION OF HUMAN HEALTH AND THE ENVIRONMENT - The University of South Carolina requires that all contractual activities to be in compliance with local, state and federal mandates concerning "protection of human health and the environment". In addition, the University of South Carolina is a "Drug Free Work Place" and requires all contractors to comply with South Carolina Code of Laws Section 41-15-10 ET sequence (1976 w/amendments). Any contractor doing business with the University will be required to document compliance with these mandates and to furnish specific information requested by the University's Department of Environmental Health and Safety when notified to do so. The Contractor understands and agrees that jobsites are open at all times work is being performed by the Contractor to authorized

University employees who have been trained to identify unsafe work conditions. The Contractor will immediately correct any deficiencies noted by these inspections when requested by the University's Department of Environmental Health and Safety to do so. In work areas where a specific hazard is posed which includes but is not limited to lead paint and asbestos abatement projects, Contractors will be required to produce Lead Compliance Plans and Asbestos Project Designs which outline their method of work prior to the start of work. Each contractor shall designate a responsible member of the Contractor's organization to be at the site whose duty shall be the prevention of accidents. By submission of this bid, the vendor agrees to take all necessary steps to insure compliance with the requirements outlined above.

# BANKRUPTCY – GOVERNMENT INFORMATION (FEB 2015)

- (a) All government information (as defined in the clause herein entitled "Information Security Definitions") shall belong exclusively to the State, and Contractor has no legal or equitable interest in, or claim to, such information. Contractor acknowledges and agrees that in the event Contractor enters into proceedings relating to bankruptcy, whether voluntary or involuntary, government information in its possession and/or under its control will not be considered property of its bankruptcy estate.
- (b) Contractor agrees to notify the State within forty-eight (48) hours of any determination that it makes to file for bankruptcy protection, and Contractor further agrees to turn over to the State, before such filing, all government information that is in Contractor's possession in a format that can be readily utilized by the State.
- (c) In order to protect the integrity and availability of government information, Contractor shall take reasonable measures to evaluate and monitor the financial circumstances of any subcontractor that will process, store, transmit or access government information. [07-7B007-1]

# CHANGES (JAN 2006):

- (1) Contract Modification. By a written order, at any time, and without notice to any surety, the Procurement Officer may, subject to all appropriate adjustments, make changes within the general scope of this contract in any one or more of the following:
- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.
- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price

Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.

(3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.

(4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1]

COMPLIANCE WITH LAWS (JAN 2006): During the term of the contract, contractor shall comply with all applicable provisions of laws, codes, ordinances, rules, regulations, and tariffs.

CONTRACTOR PERSONNEL (JAN 2006): The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them. [07-7B060-1]

CONTRACT LIMITATIONS (JAN 2006): No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR'S OBLIGATION – GENERAL (JAN 2006): The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non-professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. The contractor will be considered the sole point of contact with regard to all situations, including payment of all charges and the meeting of all other requirements. [07-7B065-1]

CONTRACTOR'S USE OF STATE PROPERTY (JAN 2006): Upon termination of the contract for any reason, the State shall have the right, upon demand, to obtain access to, and possession of, all State properties, including, but not limited to, current copies of all State application programs and necessary documentation, all data, files, intermediate materials and supplies held by the contractor. Contractor shall not use, reproduce, distribute, display, or sell any data, material, or documentation owned exclusively by the State without the State's written consent, except to the extent necessary to carry out the work. [07-7B067-1]

## DEFAULT (JAN 2006):

(a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:

- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension:
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).
- (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.
- (b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.
- (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity,
- (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.
- (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.
- (e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.
- (f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.
- (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be

adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.

(h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract.

ILLEGAL IMMIGRATION (NOV 2008): (An overview is available at www.procurement.sc.gov) By signing your offer, you certify that you will comply with the applicable requirements of Title 8, Chapter 14 of the South Carolina Code of Laws and agree to provide to the State upon request any documentation required to establish either: (a) that Title 8, Chapter 14 is inapplicable to you and your subcontractors or sub-subcontractors; or (b) that you and your subcontractors or sub-subcontractors are in compliance with Title 8, Chapter 14. Pursuant to Section 8-14-60, "A person who knowingly makes or files any false, fictitious, or fraudulent document, statement, or report pursuant to this chapter is guilty of a felony, and, upon conviction, must be fined within the discretion of the court or imprisoned for not more than five years, or both." You agree to include in any contracts with your subcontractors language requiring your subcontractors to (a) comply with the applicable requirements of Title 8, Chapter 14, and (b) include in their contracts with the sub-subcontractors language requiring the sub-subcontractors to comply with the applicable requirements of Title 8, Chapter 14. [07-7B097-1]

INDEMNIFICATION-THIRD PARTY CLAIMS - GENERAL (NOV 2011): Notwithstanding any limitation in this agreement, and to the fullest extent permitted by law, Contractor shall defend and hold harmless Indemnitees for and against any and all suits or claims of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which are attributable to bodily injury, sickness, disease or death, or to injury to or destruction of tangible property arising out of or in connection with the goods or services acquired hereunder or caused in whole or in part by any act or omission of contractor, its subcontractors, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such claims are made by a third party or an Indemnitee; however, if an Indemnitee's negligent act or omission is subsequently determined to be the sole proximate cause of a suit or claim, the Indemnitee shall not be entitled to indemnification hereunder. Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. As used in this clause, "Indemnitees" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. [07-7B100-2]

INDEMNIFICATION - THIRD PARTY CLAIMS – DISCLOSURE OF INFORMATION (FEB 2015)

- (a) Without limitation, Contractor shall defend and hold harmless Indemnitees from and against any and all suits, claims, investigations, or fines (hereinafter "action") of any character (and all related damages, settlement payments, attorneys' fees, costs, expenses, losses or liabilities) by a third party which arise out of or in connection with a disclosure of government information (as defined in the clause titled Information Security - Definitions) caused in whole or in part by any act or omission of contractor, its subcontractors at any tier, their employees, workmen, servants, agents, or anyone directly or indirectly employed by them or anyone for whose acts any of them may be liable, regardless of whether or not caused in part by an Indemnitee, and whether or not such action is brought by a third party or an Indemnitee, but only if the act or omission constituted a failure to perform some obligation imposed by the contract or the law. (b) Indemnitee must notify contractor in writing within a reasonable period of time after Indemnitee first receives written notice of any action. Indemnitee's failure to provide or delay in providing such notice will relieve contractor of its obligations under this clause only if and to the extent that such delay or failure materially prejudices contractors ability to defend such action. Indemnitee must reasonably cooperate with contractor's defense of such actions (such cooperation does not require and is without waiver of an Indemnitees attorney/client, work product, or other privilege) and, subject to Title 1, Chapter 7 of the South Carolina Code of Laws, allow contractor sole control of the defense, so long as the defense is diligently and capably prosecuted. Indemnitee may participate in contractor's defense of any action at its own expense. Contractor may not, without Indemnitee's prior written consent, settle, compromise, or consent to the entry of any judgment in any such commenced or threatened action unless such settlement, compromise or consent (i) includes an unconditional release of Indemnitee from all liability related to such commenced or threatened action, and (ii) is solely monetary in nature and does not include a statement as to, or an admission of fault, culpability or failure to act by or on behalf of, an Indemnitee or otherwise adversely affect an Indemnitee. Indemnitee's consent is necessary for any settlement that requires Indemnitee to part with any right or make any payment or subjects Indemnitee to any injunction.
- (c) Notwithstanding any other provision, contractor's obligations pursuant to this clause are without any limitation whatsoever. Contractor's obligations under this clause shall survive the termination, cancellation, rejection, or expiration of the contract. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance.
- (d) "Indemnitee" means the State of South Carolina, its instrumentalities, agencies, departments, boards, political subdivisions and all their respective officers, agents and employees. [07-7B102-1]

#### INFORMATION SECURITY - DEFINITIONS (FEB 2015)

The following definitions are used in those clauses that cross reference this clause.

Compromise means disclosure of information to unauthorized persons, or a violation of the security policy of a system in which unauthorized intentional or unintentional disclosure, modification, destruction, or loss of an object may have occurred. Without limitation, the term "compromise" includes copying the data through covert network channels, or copying the data to unauthorized media, or disclosure of information in violation of any obligation imposed by this contract.

**Data** means a subset of information in an electronic format that allows it to be retrieved or transmitted.

Government information means information (i) provided to Contractor by, or generated by Contractor for, the using governmental unit, or (ii) acquired or accessed by Contractor as a result of performing the Work. Without limiting the foregoing, government information includes any information that Contractor acquires or accesses by software or web-based services, which includes, without limitation, any metadata or location data. Government information excludes unrestricted information.

**Information** means any communication or representation of knowledge such as facts, statistics, or opinions, in any medium or form, including textual, numerical, graphic, cartographic, narrative, or audiovisual.

**Information system** means a discrete set of information resources organized for the collection, processing, maintenance, use, sharing, dissemination, or disposition of information.

**Public information** means any specific information, regardless of form or format, that the State has actively and intentionally disclosed, disseminated, or made available to the public. Information is not public information solely because it may be subject to inspection pursuant to an unfulfilled public records request.

**Software** means any computer program accessed or used by the Using Governmental Unit or a third party pursuant to or as a result of this contract.

**Third party** means any person or entity other than the Using Governmental Unit, the Contractor, or any subcontractors at any tier.

Unrestricted information means (1) public information acquired other than through performance of the work, (2) information acquired by Contractor prior to contract formation, (3) information incidental to your contract administration, such as financial, administrative, cost or pricing, or management information, and (4) any ideas, concepts, know-how, methodologies, processes, technologies, techniques which Contractor develops or learns in connection with Contractor's performance of the work.

**Web-based service** means a service accessed over the Internet and acquired, accessed, or used by the using governmental unit or a third party pursuant to or as a result of this contract, including without limitation, cloud services, software-as-a-service, and hosted computer services. [07-7B104-1]

LICENSES AND PERMITS (JAN 2006): During the term of the contract, the Contractor shall be responsible for obtaining, and maintaining in good standing, all licenses (including professional licenses, if any), permits, inspections and related fees for each or any such licenses, permits and /or inspections required by the State, county, city or other government entity or unit to accomplish the work specified in this solicitation and the contract. [07-7B115-1]

MATERIAL AND WORKMANSHIP: Unless otherwise specifically provided in this contract, all equipment, material, and articles incorporated in the work covered by this contract are to be of the most suitable grade for the purpose intended. [07-7B120-1]

OWNERSHIP OF DATA & MATERIALS (JAN 2006): All data, material and documentation either prepared for the state pursuant to this contract shall belong exclusively to the State.

PRICE ADJUSTMENTS (JAN 2006): (1) Method of Adjustment. Any adjustment in the contract price made pursuant to a clause in this contract shall be consistent with this Contract and shall be arrived at through whichever one of the following ways is the most valid approximation of the actual cost to the Contractor (including profit, if otherwise allowed):

- (a) by agreement on a fixed price adjustment before commencement of the pertinent performance or as soon thereafter as practicable;
- (b) by unit prices specified in the Contract or subsequently agreed upon;
- (c) by the costs attributable to the event or situation covered by the relevant clause, including profit if otherwise allowed, all as specified in the Contract; or subsequently agreed upon;
- (d) in such other manner as the parties may mutually agree; or,
- (e) in the absence of agreement by the parties, through a unilateral initial written determination by the Procurement Officer of the costs attributable to the event or situation covered by the clause, including profit if otherwise allowed, all as computed by the Procurement Officer in accordance with generally accepted accounting principles, subject to the provisions of Title 11, Chapter 35. Article 17 of the S.C. Code of Laws.
- (2) Submission of Price or Cost Data. Upon request of the Procurement Officer, the contractor shall provide reasonably available factual information to substantiate that the price or cost offered, for any price adjustments is reasonable, consistent with the provisions of Section 11-35-1830.

PRICING DATA – AUDIT – INSPECTION (JAN 2006): [Clause Included Pursuant to Section 11-35-1830, - 2210, & -2220] (a) Cost or Pricing Data. Upon Procurement Officer's request, you shall submit cost or pricing data, as defined by 48 C.F.R. Section 2.101 (2004), prior to either (1) any award to contractor pursuant to 11-35-1530 or 11-35-1560, if the total contract price exceeds \$500,000, or (2) execution of a change order or contract modification with contractor which exceeds \$100,000. Your price, including profit or fee, shall be adjusted to exclude any significant sums by which the state finds that such price was increased because you furnished cost or pricing data that was inaccurate, incomplete, or not current as of the date agreed upon between parties. (b) Records Retention. You shall maintain your records for three years from the date of final payment, or longer if requested by the chief Procurement Officer. The state may audit your records at reasonable times and places. As used in this subparagraph (b), the term "records" means any books or records that relate to cost or pricing data submitted pursuant to this clause. In addition to the obligation stated in this subparagraph (b), you shall retain all records and allow any audits provided for by 11-35-2220(2). (c) Inspection. At reasonable times, the state may inspect any part of your place of business which is related to performance of the work. (d) Instructions Certification. When you submit data pursuant to subparagraph (a), you shall (1) do so in accordance with the instructions appearing in Table 15-2 of 48 C.F.R. Section 15.408 (2004) (adapted as necessary for the state context), and (2) submit a Certificate of Current Cost or Pricing Data, as prescribed by 48 CFR Section 15.406-2(a) (adapted as necessary for the state context). (e) Subcontracts. You shall include the above text of this clause in all of your subcontracts. (f) Nothing in this clause limits any other rights of the state. [07-7B185-1]

RELATIONSHIP OF THE PARTIES (JAN 2006): Neither party is an employee, agent, partner, or joint venturer of the other. Neither party has the right or ability to bind the other to any

agreement with a third party or to incur any obligation or liability on behalf of the other party. [07-7B205-1]

# RESTRICTIONS ON PRESENTING TERMS OF USE OR OFFERING ADDITIONAL SERVICES (FEB 2015)

- (a) Citizens, as well as public employees (acting in their individual capacity), should not be unnecessarily required to agree to or provide consent to policies or contractual terms in order to access services acquired by the government pursuant to this contract (hereinafter "applicable services") or, in the case of public employees, to perform their job duties; accordingly, in performing the work, contractor shall not require or invite any citizen or public employee to agree to or provide consent to any end user contract, privacy policy, or other terms of use (hereinafter "terms of use") not previously approved in writing by the procurement officer. Contractor agrees that any terms of use regarding applicable services are void and of no effect.
- (b) Unless expressly provided in the solicitation, public contracts are not intended to provide contractors an opportunity to market additional products and services; accordingly, in performing the work, contractor shall not for itself or on behalf of any third party offer citizens or public employees (other than the procurement officer) any additional products or services not required by the contract.
- (c) Any reference to contractor in items (a) or (b) also includes any subcontractor at any tier. Contractor is responsible for compliance with these obligations by any person or entity that contractor authorizes to take any action related to the work.
- (d) Any violation of this clause is a material breach of contract. The parties acknowledge the difficulties inherent in determining the damage from any breach of these restrictions. Contractor shall pay the state liquidated damages of \$1,000 for each contact with a citizen or end user that violates this restriction.

(a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

- (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;
- (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident.
