### The following questions were received from Vendor A:

1. Do you have a design that you already use and works well that I could see? Even a sketch or photo?

We are looking to replace our existing 20 cubic yard recycling containers (see attached photos) with ones that will be compatible with our new truck (Ampliroll AL-95SS-12 hook lift). We basically want smaller versions of what we already have. We do not have a sketch of the container we are interested in.

2. Wheels - 8" diameter: only on the rear? (2) wheels?

We want 4 wheels on the containers, 2 in front and 2 in back.

3. RVP = Resident Vendor Preference We are in Columbia and do we qualify for that?

Please refer to Preferences – Resident Vendor Preference on pg. 5 of the Solicitation for resident vendor preference qualifications.

4. Can I meet with anyone there to see what you are using right now?

No. Please see below for the clause (Prohibited Communications and Donations) which has been added to the Solicitation.

5. You specify "Tub" style. Tub style has the bottom 20% taper inward at an angle. Is this what you want?

We prefer the tub style container for its smooth side surfaces. See attached photos of our current containers to get an idea of what we are looking for.

6. (2) OCC slots one side: Do you have the dimensions for those slots?

OCC slots should be approximately 60" wide x 6" tall

7. Load height: is this the distance from the ground to the "OCC" opening?

Load height is the distance from ground to bottom of opening. 52"load height is for the 30x30 hinged doors. Cardboard slot should be approximately centered on the slope of the container roof, but not higher than 63" off the ground.

#### The following question was received from Vendor B:

1. My company makes the small recycling containers (under 22', hooklift style), but we only make small roll offs in a square/rectangle style. Your bid requires tub style for both recycling and the open tops. Do you want me to bid what we can offer or are you 100% only using bath tub style containers? We make a 20yd and 30yd tub container, but that is it.

We prefer the tub style container due to its smooth side surfaces for easier decaling. We would be willing to consider bid(s) with rectangular containers.

## The following clause has been added to the solicitation:

PROHIBITED COMMUNICATIONS AND DONATIONS (FEB 2015)

- (b) You are advised to familiarize yourself with Regulation 19-445.2165, which restricts donations to a governmental entity with whom you have or seek to have a contract. You represent that your offer discloses any gifts made, directly or through an intermediary, by you or your named subcontractors to or for the benefit of the Using Governmental Unit during the period beginning eighteen months prior to the Opening Date.
