QUESTIONS:

Item No. Question / Answer

- 1. Question: Clarify what is included in the alternate #1 regarding the cost of lifts and scaffolding?
 - Answer: The base-bid provided for each bidder shall **exclude** the cost associated with all lifts and scaffolding required to install the wall mounted flooring. This equipment shall be provided by the University of South Carolina, including hoist equipment from bridge / catwalk above. Each bidder shall provide an alternate price (#1) to provide any and all lifts, scaffolding, and hoists necessary to complete the installation of the work, including delivery, set-up charges, and removal of all equipment. It is assumed that the scaffolding will be installed on-time and remain in place until the work is complete and then removed.
- 3. Question: Who will be responsible for transporting the existing flooring to the fabricator's shop?
 - Answer: Each bidder shall include in the cost of their base bid all costs associated with transporting the existing flooring to and from their shop in order to work with and modify the existing panels necessary to complete the work. The loading dock of the Colonial Life Arena is available for use during the transportation of the flooring as well as other materials associated with the work.

- 4. Question: Can information on the existing flooring manufacturer and system be provided?
 - Answer: The existing flooring system was manufactured by Connor Sports and is the "QUICKLOCK Portable System" made up of a 1x4 sleepers, a 7/16" subfloor and 25/32" maple gym flooring. See the attached Spec Sheet from Connor Sport.
- 5. Question: Are the concealed "Z" clips individual or continuous

Answer: It is the intent of the Architect that the clips are continuous, however this is a Means and Methods issue that will be the responsibly of each bidder / fabricator / installer. There are many factors that will determine the layout of the support clips such as the overall total weight of each panel, the number of clips, the spacing of the flooring sleepers, etc. The layout and design of the mounting method will be the responsibility of each bidder / fabricator / installer.

- 6. Question: HVAC work, is all of what is shown on sheet, M1.01 to be included in the bid or just capping of duct work behind the new work?
 - Answer: There is no Mechanical scope of work associated with this project from Sheet M1.01. Refer to notes on Drawing 1 / A2.06 for the entire Mechanical scope of this project which includes removing the existing louvered grilles and installing an insulated panel and then reinstalling the grille.
- 7. Question: Does the steel skeleton have to be painted a "finish" color or is primer acceptable?
 - Answer: The Steel Frame is to be concealed from view and does not need to be painted or primed. Unfinished Steel is acceptable.
