ITEM ONE:

QUESTION: I am working on the flooring portion (LOT B) of the bid and I've noticed several line items that were left off of the bid price sheet (pg. 28).

We also noticed that the quantity on the price list for No. 003 "Smash Tile" is listed as Square Feet. The project will actually need much more than 115sqft. The quantity on our quote is "115 EACH". The Smash Tiles are 4 SqFt Each, so USC would need 115 TILES or 460 SQFT of Smash Tiles to complete this area of the floor.

Item 0001: RallyRoll Grey 20% (14.5mm) - Custom

Dimensions: 14.5mm product combines a 2.5mm wear layer with a 12mm shock absorbing base layer.

Description: Flooring must be tailored for heavy conditioning, this 14.5mm product combines a 2.5mm wear layer with a 12mm shock absorbing base layer. Must showcase a dynamic force reduction of 35.40%. This dual durometer system is engineered to absorb the impact force related to aggressive functional training, providing an ergonomically advanced surface that works in concert with the body. This product must be a custom color while using our Grippin' Gray 20% -- RALG20.

ITEM 0002: Adhesive – 4gal (for weight room)

Dimensions: four gallons

Description: Installation of flooring must use E-Grip Adhesive and Henry 440 Cove Base Adhesive.

ITEM 0003: SmashTile Grey 20% - 2.5"

Dimensions: 2-foot by 2-foot by 2.5-inch molded tile.

Description: • This product must be a 2-foot by 2-foot by 2.5-inch molded tile. SmashTile will sustain the repeated abuse of extreme weights without dimpling, tearing, or fading. This specific product eliminates the shock and sound resulting from large weight being thrown onto its surface by absorbing it. Dimensions: 8'x6' Platform with custom logo using 2-foot by 2-foot by 2.5-inch molded tile

Description: This product must be a 2-foot by 2-foot by 2.5-inch molded tile. SmashTile will sustain the repeated abuse of extreme weights without dimpling, tearing, or fading. This specific product eliminates the shock and sound resulting from large weight being thrown onto its surface by absorbing it. Must use Ecore's Quad Blok interlocking system, which offers reliable easy-down / easy-up installation. The logos will use Ecore's EL00, Black as well as EL1820, Maroon.

ITEM 0005: Speed & Agility Turf (12mm)

Dimensions: 12ft x 60ft area with 12mm turf

Description: Turf must feature a dense, textured nylon wear layer which is fusion bonded to a 5mm recycled rubber base layer. This product passes the ASTM D-5034 Tear Strength test of >200 pounds.

ITEM 0006: Rolled Grippin Grey 10 (8mm) (Balcony)

Dimensions: 9ft x 145ft area using 8mm rubber flooring

Description: Everlast Basic Rolls and Tiles are the "original" recycled rubber fitness floor. Available in rolls and tiles, this durable surface sets the standard for performance, quality, and affordability. This product is coded at EL02 which uses the 0-10% color margin and cannot be anything else. This product will be used in the upstairs cardio deck only in Blatt Gymnasium. Ecore's 8mm Everlast can only be installed using E-Grip Adhesive.

ITEM 0007: Rolled Grippin Grey 10 (6mm) (2ft Wall Base)

Dimensions: 2ft height around base of facility of 6mm rubber flooring

Description: Everlast Basic Rolls and Tiles are the “original” recycled rubber fitness floor. Available in rolls and tiles, this durable surface sets the standard for performance, quality, and affordability. This product is coded at EL02 which uses the 0-10% color margin and cannot be anything else. This product will specifically be used for a cove base which will surround the entire lower part of the wall in Blatt Gymnasium. Ecore’s 6mm Everlast can only be installed to the wall using Henry 440 Cove Base Adhesive.

ITEM 0008: E-Stripper - 1gal (for weight room floor)

Dimensions: one gallon

Description: Fast acting with low odor, E-Strip removes multiple layers of finish, without harsh alkalies and other conventional components. E-Strip is available in a one-gallon container.

ITEM 0009: SmashTile Basic Black Reducer

Dimensions: 2.5" x 8" x 48" and 1" x 4" x 48"
