New Online Solicitation System

The Purchasing Department is pleased to announce that our new online solicitation and bidding system is now live. This new web-based software system is used by the Purchasing Department to create online solicitation events, accept electronic bids and proposals, and issue notices of award for procurement contracts resulting from the solicitations. This new system completely replaces the legacy method of posting solicitations directly to our department website.

This new system provides:

- access to a public Supplier Portal (<u>supplier.ps.sc.edu</u>) where USC Solicitation Opportunities and Award Statements are published.
- an electronic registration process for prospective suppliers to become "Offerors" in the USC solicitation system.
- the ability to create and submit electronic responses to Solicitations, by both *Offerors* and existing USC *Suppliers*.

There was a 2-phase rollout for this new system:

- Phase 1 began March 1, 2021 All vendors interested in doing business with the university may register as an <u>Offeror</u> (or request a Supplier <u>User ID</u> for vendors that <u>already exist in the</u> <u>university's supplier database</u>).
- Phase 2 began March 15, 2021 All registered Offerors or Suppliers have the ability to submit bids and proposals directly online via the Supplier Portal of this new system.

The public access point for all *new* Procurement activity (i.e. Solicitations and Awards) on or after March 15, 2021, will be posted and maintained within the university's <u>Supplier Portal</u>. On the Supplier Home Page, public users will be able to view active solicitation events, as well as view more information about Supplier and Offeror registration, including instruction guides and frequently asked questions and answers.

Through the use of the Fixed Price Bid, the University shall establish a list of qualified service providers from which to utilize as contractors for specific jobs. There shall be no guarantee of work for any of the qualified Contractors.[01-1005-1]

III. SCOPE OF WORK/SPECIFICATIONS

SCOPE OF WORK

A. Overview/History

The University of South Carolina currently has a combination of methods by which to have groundskeeping services for the Columbia and system campuses. The University reserves the right to exclude services for any campus, in which the service will exceed the Total Potential Value of \$500,000.00.

For the purposes of this contract, the pricing provided in Section VIII, Bid Schedule will include the following services:

- 1. Grass cutting
- 2. Blowing
- 3. Lawn edging
- 4. Hedge clipping
- 5. Leaf removal
- 6. Tree pruning
- 7. Litter control
- 8. Emergency clean-up
- 9. Placement of pine straw or wood chips
- 10. Weed control
- 11. Flower maintenance and planting
- 12. Irrigation maintenance

Maximum pricing under the terms of the resulting contract shall be limited to \$100.00 per hour for each person working onsite in each instance. Pricing for services completed in a half hour shall be limited to \$50.00 for that 30-minute time period.

B. General Scope of Project

The Contractor shall furnish all materials, equipment, and manpower to adequately perform the work of this contract as specified by each location as needed in the subsequent agreements, which follow.

C. Program Goals and Desired Results

The primary purpose of the solicitation is to acquire multiple supplier sources to provide groundskeeping services across all campuses. As opportunities become available, Contractors will be provided with a complete job description and goals prior to acceptance and completion of a specific agreement for a job.

D. Contracting Officer Representative

The University shall assign a Contracting Officer Representative (COR) for each subsequent agreement.

- 1. The COR may be changed at any time by the University without prior notice to the contractor and without modification to the contract. At a minimum, the University shall provide the contractor with the COR's information:
- 2. The responsibilities and limitations of the COR are as follows:
 - a. The COR is responsible for the technical aspects of the contract and serves as technical liaison with the contractor and Procurement Officer. The COR is also responsible for the final inspection and acceptance of all deliverables and such other responsibilities as may be specified in the contract.
 - b. The COR is not authorized to make any commitments or otherwise obligate the State or authorize any changes which affect the contract price, terms or conditions. Any contractor request for changes shall be referred to the Procurement Officer directly or through the COR. No such changes shall be made without the express written prior authorization of the Procurement Officer. The Procurement Officer may designate assistant or alternate COR(s) to act for the COR by naming such assistant/alternate(s) in writing and transmitting a copy of such designation to the contractor.

E. Work Schedules

Work schedule will be based on the university's calendar for opening and closing of school. The start and completion dates will be communicated to Contractors prior to agreement/commencement of work. The University will provide details of the work schedule during the pre-conference meeting with Contractors. Scheduled coordination will occur prior to commencement of work, to determine areas of work to maximize efficiency of schedule.

F. Current Level of Performance

Currently, the University has multiple contracts for groundskeeping services as required by each of the locations. This University ultimately seeks to collect all of the services needed under the umbrella of this one solicitation as the existing contracts terminate. Previous solicitations for groundskeeping services may be viewed on the University's website: Solicitations and Awards - Purchasing | University of South Carolina (sc.edu)

As the University finds the need for services, each program area shall contact provider(s) to solicit final pricing and to establish the scope of work specific to their needs. Prior to issuing a purchase order, the contractor and University representative (COR) shall complete a subsequent agreement, which establishes their agreed understanding of the performance and payment expectations.

G. Minimum Level of Success

Unless specified differently on the subsequent agreement, Contractors shall adhere to the scope of work provided below:

1. General Maintenance:

There will be no usage of fertilizer in any form. Only a pre/post emergence will be used.

Requirements for grounds preparation for special events will be coordinated with the Contractor to permit normal work schedule to be adapted to meet needs. Where extra service is required, the Contractor shall provide such services at an agreed upon rate between the Contractor and the Contracting Officer Representative. This cost will be provided as a per-acre cost along with the project bid.

Grounds will be available for services during daylight hours, seven days a week.

2. Grass cutting:

An acceptably cut grassed area shall be cut to a uniform height. Mowers will be set to cut grass to a height of no more than three (3) inches and not less than two (2) inches. The grass shall not be scalped, unevenly mowed, and the ground shall not be rutted by equipment. Trees and shrubs shall not be damaged. The Contactor shall repair or replace turf, shrubs, trees and fences, which have been damaged during mowing operations within fifteen (15) calendar days of damage. Sidewalks, curbs, gutters, storm inlets and drives shall be free of grass cuttings as determined by the Field Maintenance Supervisor. Mow and trim all grassed areas as indicated in schedule from March to November and from December to February (except inclement weather periods). All excessive grass clippings will be removed and disposed of away from college grounds. Cutting frequency shall be weekly March thru November and Bi-monthly (mostly for leaf pickup) December thru February unless otherwise negotiated. Treatment of Fire Ants will be provided weekly, on an as needed basis after grass cutting.

3. Drainage Ditches:

Vegetation in and adjacent to the drainage ditches on improved grounds shall be mowed to the same standards as for the adjacent grass cutting. Ditches without water shall have the entire area mowed. Those with standing water in them will be mowed to within six (6) inches to twelve (12) inches of the waterline. All vines, shrubs and trees shall be removed. Drainage ditches shall be mowed at the same time that the adjacent grassed areas are mowed.

4. Grass And Weed Trimming:

The grass and weeds shall be trimmed around structures and objects that cannot be mowed around during the grass cutting operation. Trimming shall be done on the same date that the adjacent grass is cut. Chemicals may be used around buildings, fences, trees, and other objects with a kill zone of not more than six (6) inches from objects. Grass and weeds penetrating or overlapping pavement surfaces will be chemically removed.

5. Herbicides Used:

The Contractor shall use only herbicides that are registered with the USEPA for the use intended and which are approved by the Facilities Administrator. The Contractor will use all herbicides in strict conformance with MSDS labels book of all herbicides used and have it readily available for reference on site at all times for review. Contractors must be certified by the state of South Carolina through Clemson Extension Services to spray controlled herbicides and must also provide a copy of the current certification (annually) prior to renewal of the contract. Contractor shall be responsible for any damage occurring to University property as a result of chemicals used to perform under the terms of the Contract.

6. Policing Grounds and Paved Areas:

Prior to mowing the contract area, the Contractor shall pick up and dispose of trash and litter on all improved grounds and paved areas. Trash and litter includes paper, plastic, bottles, cans, cardboard, rags, limbs, sticks and other similar solid materials and foreign debris. An acceptably policed area shall be free of such trash and litter. The contractor will vacuum or blow the parking lots

7. <u>Shrubbery Maintenance:</u>

Hedge trimming will occur four (4) times a year: January, April, July and October by the last day of the months, respectively.

Pine Straw will be placed around <u>all existing shrubbery</u> four (4) times a year: January, April, July and October (by the last day of the month, respectively). Installation of pine straw will require at least two (2) inches of pine straw coverage on all shrubbery.

H. Protection of University Property

- 1. If at any time, proper precautions have not been taken to provide adequate protection to university property, the Contractor will be advised by the Contracting Officer Representative of specific locations and problems. Work must cease immediately, within the particular space(s), until such protections have been installed. Whether initial or supplemental protections are provided, all protection shall be at no additional cost to the University.
- 2. Contractors must take reasonable care to protect all finish hardware, windows, doors, landscaping, sidewalks, light fixtures, and other University property from damage. Contractor acknowledges full responsibility for any deformities, irregularities, or damage caused by their contracted work. Contractor shall bear the cost to correct any damages to the extent of the University's determination
- 3. The Contractor must survey and inform the COR of any pre-existing damage, within the work areas, prior to starting work. The Contractor is strongly encouraged to take pictures of items considered to be damaged, prior to starting and assignment and submit them to the COR for verification. If at any time throughout the duration of the project, damage is identified by University personnel and has not been

documented, the Contractor must assume responsibility for any repair and/or replacement of the item.

- 4. The Contractor or employees are not allowed play any musical devices (radios, boom boxes, phones through speakers, Bluetooth speakers, etc.) in the work site.
- 5. The Contractor must keep sidewalks and parking areas cleared of work materials and debris, at all times.
- 6. The Contractor is responsible for any and all damage, caused by a lack of protection and/or procedures. The Contractor must replace, repair and/or clean, at no additional cost to the University, any damaged property to its original state.
- 7. All items moved, in the course of the Contractor's work, are to be replaced to its original location and ready for use.

I. <u>University Provisions</u>

1. Utilities Access

The University will provide electricity and water supply at the jobsite through existing receptacles and fixtures but without any provision which allows workers to directly tap circuit panels. The Contractor must supply its own extension cords, water hoses and other equipment as required by the work scope.

2. Parking

The University of South Carolina Department of Public Safety (DPS) or Parking Services may exercise authority to direct parking due to event or safety concerns. Any vendors with concerns regarding parking should contact the Campus's DPS directly.

J. Milestone Dates

When appropriate, milestone dates will be established for special projects prior to the Contractor's acceptance or commencement of work.

K. Staffing Plan

- 1. The Contractor shall be fully responsible for the acts and omissions of its Subcontractors and of persons employed by them, while on University Property, and will be held accountable for any conduct that violates University Policy.
- 2. In accordance with University Policy, sexual harassment, discrimination and the use of alcohol or drugs is strictly forbidden. Refer to: http://www.sc.edu/policies/policiesbydivision.php for policy details.
- 3. The Contractor must submit a Criminal Background check for each employee and/or subcontractor(s) prior to employee and/or subcontractor performing contract work on campus. The background check must include criminal conviction check (County,

State, Federal) and sex and violent offender registry check. The cost of background checks will be paid by the Contractor. The University of South Carolina shall not accept any employees with a history of violent or sexually deviant offenses; and reserves the right to reject applicants who have previous criminal convictions. Such judgements shall be made on a case-by-case basis. Contractors must have prior written approval by the COR for every candidate prior to his or her commencement of work on any University campus.

- 4. The Contractor and its staff shall have a form of identification on them at all times, while on University property; and shall be easily recognizable as an employee assigned to the campus facility.
- 5. Fraternization between the Contractor's employees and USC students, faculty or staff is strictly prohibited and addressed with zero-tolerance.
- 6. The UofSC will not tolerate rude, abusive, or degrading behavior on the job site. Inappropriate communications directed towards students, faculty, or staff, or any other person on University property is strictly prohibited.
- 7. Use of The UofSC communications facilities (telephone, computers, etc.) by the Contractor is prohibited, unless prior arrangements are made with the COR.
- 8. The Contractor will have one point of contact for the duration of each agreement. That person shall be the Contractor Officer Representative (COR). At no time is the Contractor to ask questions or take direction from any other individuals. Should an incident occur where they are approached by University staff, the Contractor must direct that person to the COR.
- 9. The Contractor must have the ability to communicate effectively and efficiently to University Representatives.
- 10. Proper attire must be worn at all times. All employees shall present a professional image when working on campus. Employees wearing clothing with abusive, profane, political, or divisive language will not be tolerated. Clothing with large and graphic images are not acceptable unless it is the Carolina logo. Tank tops, shorts and open toe shoes are not permitted on site, at any time. Personnel shall not wear clothing, which represents Institutions of Higher Education other than that of the University of South Carolina.
- 11. The Contractor is responsible for removal of all waste from the site. Waste must not be placed in the University dumpsters unless pre-approved by the COR.
- 12. The Contractor must not allow its workers and Subcontractors to dispose any food waste/items into its construction dumpster to prevent potential rodent infestation of the dumpster.
- 13. Additional staff expectations:
 - a. Must be productive in the workplace for the paid time.
 - b. Must have good work ethic

L. Communications Plan

- 1. Kickoff/Pre-Conference Meeting will be convened by the University This meeting will review responsibilities, contractor assignments, and items affecting project progress. The University will announce the place and time of the meeting.
- 2. Progress meetings and reports may be required for special projects.
- 3. The University reserves the right to call meetings at any time to discuss Contractor performance and expectations. Such meetings may occur with 24 hours' notice and may be virtual or face to face at the discretion of the University. Contractors shall comply with meeting request and shall provide an appropriate level representative for the meeting (Owner, CEO, Region Manager).

M. Change Management Process

Unless otherwise specified, all changes to the work schedule, duties, and key employees must be approved in writing by the COR.

The University of South Carolina reserves the right to modify subsequent agreements based on the need of the campus or facilities, including unexpected closures and decreases in student enrollment.

N. Payment

Contractors shall submit itemized invoices to the Contracting Officer representatives:

- 1. Contractors providing regular groundskeeping services shall submit monthly invoices unless otherwise approved in writing by the COR.
- 2. Contractors providing services for special projects shall submit statements within thirty days after completion of the project. If appropriate, the University reserves the right to establish milestone or scheduled payments prior to the Contractor's acceptance and commencement of work.
- 3. At a minimum, invoices shall demonstrate the actual date and times (beginning end) that services were performed, a description of the services provided, location, number of employees onsite, and itemized pricing for additional materials provided as specified in Bullet O (add-on services).

O. Add-On Services

The University of South Carolina reserves the right to procure related add-on services such as grass installation, planting flower beds, etc. Such services shall be subject to the terms

and conditions of the resulting contract; and shall be specified through an informal quote method solicited from three Contractor awarded from this solicitation. While the prices for add-on services shall be the same as specified here-in, Contractor may quote higher fees for the services of specialized professionals (such as landscape artists) and shall provide a quote for additional materials (flowers, sod, pine straw, wood chips, rocks and stones, shrubbery, etc.) needed to provide the services requested by the University.

Notwithstanding the foregoing, contractor may assign monies receivable under the contract provided that the state shall have no obligation to make payment to an assignee until thirty days after contractor (not the assignee) has provided the responsible procurement officer with (i) proof of the assignment, (ii) the identity (by contract number) of the specific state contract to which the assignment applies, and (iii) the name of the assignee and the exact address or account information to which assigned payments should be made. Unless otherwise specified herein, including the purchase order, payment shall not be made on partial deliveries accepted by the Government. (b) Unless otherwise provided herein, including the purchase order, payment will be made by check mailed to the payment address on "Page Two." (c) Notwithstanding any other provision, payment shall be made in accordance with S.C. Code Section 11-35-45, or Chapter 6 of Title 29 (real property improvements) when applicable, which provides the Contractor's exclusive means of recovering any type of interest from the Owner. Contractor waives imposition of an interest penalty unless the invoice submitted specifies that the late penalty is applicable. Except as set forth in this paragraph, the State shall not be liable for the payment of interest on any debt or claim arising out of or related to this contract for any reason. (d) Amounts due to the State shall bear interest at the rate of interest established by the South Carolina Comptroller General pursuant to Section 11-35-45 ("an amount not to exceed fifteen percent each year"), as amended, unless otherwise required by Section 29-6-30. (e) Any other basis for interest, including but not limited to general (pre- and post-judgment) or specific interest statutes, including S.C. Code Ann. Section 34-31-20, are expressly waived by both parties. If a court,

despite this agreement and waiver, requires that interest be paid on any debt by either party other than as provided by items (c) and (d) above, the parties further agree that the applicable interest rate for any given calendar year shall be the lowest prime rate as listed in the first edition of the Wall Street Journal published for each year, applied as simple interest without compounding. (f) The State shall have all of its common law, equitable and statutory rights of set-off. [07-7A055-3]

PUBLICITY (JAN 2006)

Contractor shall not publish any comments or quotes by State employees, or include the State in either news releases or a published list of customers, without the prior written approval of the Procurement Officer. [07-7A060-1]

PURCHASE ORDERS (JAN 2006)

Contractor shall not perform any work prior to the receipt of a purchase order from the using governmental unit. The using governmental unit shall order any supplies or services to be furnished under this contract by issuing a purchase order. SURVIVAL OF OBLIGATIONS (JAN 2006)

The Parties' rights and obligations which, by their nature, would continue beyond the termination, cancellation, rejection, or expiration of this contract shall survive such termination, cancellation, rejection, or expiration, including, but not limited to, the rights and obligations created by the following clauses: Indemnification - Third Party Claims, Intellectual Property Indemnification, and any provisions regarding warranty or audit. TAXES (JAN 2006)

- (a) drawings, designs, or specifications, if the supplies to be furnished are to be specially manufactured for the [State] in accordance therewith;
- (b) method of shipment or packing;
- (c) place of delivery;
- (d) description of services to be performed;
- (e) time of performance (i.e., hours of the day, days of the week, etc.); or,
- (f) place of performance of the services. Subparagraphs (a) to (c) apply only if supplies are furnished under this contract. Subparagraphs (d) to (f) apply only if services are performed under this contract.
- (2) Adjustments of Price or Time for Performance. If any such change increases or decreases the contractor's cost of, or the time required for, performance of any part of the work under this contract, whether or not changed by the order, an adjustment shall be made in the contract price, the delivery schedule, or both, and the contract modified in writing accordingly. Any adjustment in contract price made pursuant to this clause shall be determined in accordance with the Price Adjustment Clause of this contract. Failure of the parties to agree to an adjustment shall not excuse the contractor from proceeding with the contract as changed, provided that the State promptly and duly make such provisional adjustments in payment or time for performance as may be reasonable. By proceeding with the work, the contractor shall not be deemed to have prejudiced any claim for additional compensation, or an extension of time for completion.
- (3) Time Period for Claim. Within 30 days after receipt of a written contract modification under Paragraph (1) of this clause, unless such period is extended by the Procurement Officer in writing, the contractor shall file notice of intent to assert a claim for an adjustment. Later notification shall not bar the contractor's claim unless the State is prejudiced by the delay in notification.
- (4) Claim Barred After Final Payment. No claim by the contractor for an adjustment hereunder shall be allowed if notice is not given prior to final payment under this contract. [07-7B025-1]

CONTRACT LIMITATIONS (JAN 2006)

No sales may be made pursuant to this contract for any item or service that is not expressly listed. No sales may be made pursuant to this contract after expiration of this contract. Violation of this provision may result in termination of this contract and may subject contractor to suspension or debarment. [07-7B045-1]

CONTRACTOR'S LIABILITY INSURANCE - GENERAL (FEB 2015)

- (a) Without limiting any of the obligations or liabilities of Contractor, Contractor shall procure from a company or companies lawfully authorized to do business in South Carolina and with a current A.M. Best rating of no less than A: VII, and maintain for the duration of the contract, insurance against claims for injuries to persons or damages to property which may arise from or in connection with the performance of the work and the results of that work by the contractor, his agents, representatives, employees or subcontractors.
- (b) Coverage shall be at least as broad as:
- (1) Commercial General Liability (CGL): Insurance Services Office (ISO) Form CG 00 01 12 07 covering CGL on an "occurrence" basis, including products-completed operations, personal and advertising injury, with limits no less than \$1,000,000 per occurrence. If a general aggregate limit applies, the general aggregate limit shall be twice the required occurrence limit. This contract shall be considered to be an "insured contract" as defined in the policy.
- (2) Auto Liability: ISO Form Number CA 00 01 covering any auto (Code 1), or if Contractor has no owned autos, hired, (Code 8) and non-owned autos (Code 9), with limits no less than \$1,000,000 per accident for bodily injury and property damage.
- (3) Worker's Compensation: As required by the State of South Carolina, with Statutory Limits, and Employer's Liability Insurance with limit of no less than \$1,000,000 per accident for bodily injury or disease.
- (c) Every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them, must be covered as additional insureds on the CGL policy with respect to liability arising out of work or operations performed by or on behalf of the Contractor including materials, parts or equipment furnished in connection with such work or operations. General liability coverage can be provided in the form of an endorsement to the Contractor's insurance at least as broad as ISO Form CG 20 10 11 85 or if not available, through the addition of both CG 20 10 and CG 20 37 if a later edition is used.
- (d) For any claims related to this contract, the Contractor's insurance coverage shall be primary insurance as respects the State, every applicable Using Governmental Unit, and the officers, officials, employees and volunteers of any of them. Any insurance or self-insurance maintained by the State, every applicable Using Governmental Unit, or the officers, officials, employees and volunteers of any of them, shall be excess of the Contractor's insurance and shall not contribute with it.
- (e) Prior to commencement of the work, the Contractor shall furnish the State with original certificates and amendatory endorsements or copies of the applicable policy language effecting coverage required by this section. All certificates are to be received and approved by the State before work commences. However, failure to obtain the required documents prior to the work beginning shall not waive the Contractor's obligation to provide them. The State reserves the right to require complete, certified copies of all required insurance policies, including endorsements required by this section, at any time.
- (f) Should any of the above described policies be cancelled before the expiration date thereof, notice will be delivered in accordance with the policy provisions. In addition, the Contractor shall notify the State immediately upon receiving any information that any of the coverages required by this section are or will be changed, cancelled, or replaced.
- (g) Contractor hereby grants to the State and every applicable Using Governmental Unit a waiver of any right to subrogation which any insurer of said Contractor may acquire against the State or applicable Using Governmental Unit by virtue of the payment of any loss under such

insurance. Contractor agrees to obtain any endorsement that may be necessary to effect this waiver of subrogation, but this provision applies regardless of whether or not the State or Using Governmental Unit has received a waiver of subrogation endorsement from the insurer.

- (h) Any deductibles or self-insured retentions must be declared to and approved by the State. The State may require the Contractor to purchase coverage with a lower deductible or retention or provide proof of ability to pay losses and related investigations, claim administration, and defense expenses within the retention.
- (i) The State reserves the right to modify these requirements, including limits, based on the nature of the risk, prior experience, insurer, coverage, or other special circumstances. [07-7B056-2]

CONTRACTOR PERSONNEL (JAN 2006)

The Contractor shall enforce strict discipline and good order among the Contractor's employees and other persons carrying out the Contract. The Contractor shall not permit employment of unfit persons or persons not skilled in tasks assigned to them.

CONTRACTOR'S OBLIGATION - GENERAL (JAN 2006)

The contractor shall provide and pay for all materials, tools, equipment, labor and professional and non- professional services, and shall perform all other acts and supply all other things necessary, to fully and properly perform and complete the work. The contractor must act as the prime contractor and assume full responsibility for any subcontractor's performance. DEFAULT (JAN 2006)

- (a) (1) The State may, subject to paragraphs (c) and (d) of this clause, by written notice of default to the Contractor, terminate this contract in whole or in part if the Contractor fails to:
- (i) Deliver the supplies or to perform the services within the time specified in this contract or any extension;
- (ii) Make progress, so as to endanger performance of this contract (but see paragraph (a)(2) of this clause); or
- (iii) Perform any of the other material provisions of this contract (but see paragraph (a)(2) of this clause).
- (2) The State's right to terminate this contract under subdivisions (a)(1)(ii) and (1)(iii) of this clause, may be exercised if the Contractor does not cure such failure within 10 days (or more if authorized in writing by the Procurement Officer) after receipt of the notice from the Procurement Officer specifying the failure.

- (b) If the State terminates this contract in whole or in part, it may acquire, under the terms and in the manner the Procurement Officer considers appropriate, supplies or services similar to those terminated, and the Contractor will be liable to the State for any excess costs for those supplies or services. However, the Contractor shall continue the work not terminated.
- (c) Except for defaults of subcontractors at any tier, the Contractor shall not be liable for any excess costs if the failure to perform the contract arises from causes beyond the control and without the fault or negligence of the Contractor. Examples of such causes include (1) acts of God or of the public enemy, (2) acts of the State in either its sovereign or contractual capacity, (3) fires, (4) floods, (5) epidemics, (6) quarantine restrictions, (7) strikes, (8) freight embargoes, and (9) unusually severe weather. In each instance the failure to perform must be beyond the control and without the fault or negligence of the Contractor.
- (d) If the failure to perform is caused by the default of a subcontractor at any tier, and if the cause of the default is beyond the control of both the Contractor and subcontractor, and without the fault or negligence of either, the Contractor shall not be liable for any excess costs for failure to perform, unless the subcontracted supplies or services were obtainable from other sources in sufficient time for the Contractor to meet the required delivery schedule.
- (e) If this contract is terminated for default, the State may require the Contractor to transfer title and deliver to the State, as directed by the Procurement Officer, any (1) completed supplies, and (2) partially completed supplies and materials, parts, tools, dies, jigs, fixtures, plans, drawings, information, and contract rights (collectively referred to as "manufacturing materials" in this clause) that the Contractor has specifically produced or acquired for the terminated portion of this contract. Upon direction of the Procurement Officer, the Contractor shall also protect and preserve property in its possession in which the State has an interest.
- (f) The State shall pay contract price for completed supplies delivered and accepted. The Contractor and Procurement Officer shall agree on the amount of payment for manufacturing materials delivered and accepted and for the protection and preservation of the property; if the parties fail to agree, the Procurement Officer shall set an amount subject to the Contractor's rights under the Disputes clause. Failure to agree will be a dispute under the Disputes clause. The State may withhold from these amounts any sum the Procurement Officer determines to be necessary to protect the State against loss because of outstanding liens or claims of former lien holders.
- (g) If, after termination, it is determined that the Contractor was not in default, or that the default was excusable, the rights and obligations of the parties shall, if the contract contains a clause providing for termination for convenience of the State, be the same as if the termination had been issued for the convenience of the State. If, in the foregoing circumstances, this contract does not contain a clause providing for termination for convenience of the State, the contract shall be adjusted to compensate for such termination and the contract modified accordingly subject to the contractor's rights under the Disputes clause.
- (h) The rights and remedies of the State in this clause are in addition to any other rights and remedies provided by law or under this contract. [07-7B075-1]

ESTIMATED QUANTITY - UNKNOWN (JAN 2006)

The total quantity of purchases of any individual item on the contract is not known. The State does not guarantee that the State will buy any specified item or total amount. The omission of an estimated purchase quantity does not indicate a lack of need but rather a lack of historical information. [07-7B095-1]

Contractor shall be given timely written notice of any suit or claim. Contractor's obligations hereunder are in no way limited by any protection afforded under workers' compensation acts, disability benefits acts, or other employee benefit acts. This clause shall not negate, abridge, or reduce any other rights or obligations of indemnity which would otherwise exist. The obligations of this paragraph shall survive termination, cancelation, or expiration of the parties' agreement. This provision shall be construed fairly and reasonably, neither strongly for nor against either party, and without regard to any clause regarding insurance. RESTRICTIONS ON PRESENTING TERMS OF USE OR OFFERING ADDITIONAL SERVICES (FEB 2015)

TERM OF CONTRACT - OPTION TO RENEW (JAN 2015)

(a) At the end of the initial term, and at the end of each renewal term, this contract shall automatically renew for a period of Four (4) years, unless contractor receives notice that the state elects not to renew the contract at least thirty (30) days prior to the date of renewal. The contractor shall, upon direction of

the Procurement Officer, protect and preserve property in the possession of the contractor in which the State has an interest. If the Procurement Officer does not exercise this right, the contractor shall use best efforts to sell such supplies and manufacturing materials in a accordance with the standards of Uniform Commercial Code Section 2-706. Utilization of this Section in no way implies that the State has breached the contract by exercise of the Termination for Convenience Clause.

- (4) Compensation. (a) The contractor shall submit a termination claim specifying the amounts due because of the termination for convenience together with cost or pricing data required by Section 11-35-1830 bearing on such claim. If the contractor fails to file a termination claim within one year from the effective date of termination, the Procurement Officer may pay the contractor, if at all, an amount set in accordance with Subparagraph (c) of this Paragraph.

 - (iii) reasonable costs of settling and paying claims arising out of the termination of subcontracts or orders pursuant to Paragraph (2) of this clause. These costs must not include costs paid in accordance with Subparagraph (c)(ii) of this paragraph;
- (iv) any other reasonable costs that have resulted from the termination. The total sum to be paid the contractor under this Subparagraph shall not exceed the total contract price plus the reasonable settlement costs of the contractor reduced by the amount of payments otherwise made, the proceeds of any sales of supplies and manufacturing materials under Subparagraph (b) of this Paragraph, and the contract price of work not terminated.
- (d) Contractor must demonstrate any costs claimed, agreed to, or established under Subparagraphs (b) and (c) of this Paragraph using its standard record keeping system, provided such system is consistent with any applicable Generally Accepted Accounting Principles.
- (5) Contractor's failure to include an appropriate termination for convenience clause in any subcontract shall not (i) affect the State's right to require the termination of a subcontract, or (ii) increase the obligation of the State beyond what it would have been if the subcontract had contained an appropriate clause.

IMPORTANT TAX NOTICE - NONRESIDENTS ONLY

Withholding Requirements for Payments to Nonresidents: Section 12-8-550 of the South Carolina Code of Laws requires persons hiring or contracting with a nonresident conducting a business or performing personal services of a temporary nature within South Carolina to withhold 2% of each payment made to the nonresident. The withholding requirement does not apply to (1) payments on purchase orders for tangible personal property when the payments are not accompanied by services to be performed in South Carolina, (2) nonresidents who are not conducting business in South Carolina, (3) nonresidents for contracts that do not exceed \$10,000 in a calendar year, or (4) payments to a nonresident who (a) registers with either the S.C. Department of Revenue or the S.C. Secretary of State and (b) submits a Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to the person letting the contract.

The withholding requirement applies to every governmental entity that uses a contract ("Using Entity"). Nonresidents should submit a separate copy of the Nonresident Taxpayer Registration Affidavit - Income Tax Withholding, Form I-312 to every Using Entity that makes payment to the nonresident pursuant to this solicitation. Once submitted, an affidavit is valid for all contracts between the nonresident and the Using Entity, unless the Using Entity receives notice from the Department of Revenue that the exemption from withholding has been revoked.

Section 12-8-540 requires persons making payment to a nonresident taxpayer of rentals or royalties at a rate of \$1,200.00 or more a year for the use of or for the privilege of using property in South Carolina to withhold 7% of the total of each payment made to a nonresident taxpayer who is not a corporation and 5% if the payment is made to a corporation.
