### 4. Faculty Senate – Simmons

Both President Amiridis and Provost Arnett began their reports with reviews of highpoints in the previous year, including increasing rates of fundraising and research, hiring (finally) of new deans and the restructuring of the Provost's office (with the addition of a new faculty ombudsperson as well as a faculty affairs post).

Of particular interest: Amiridis is working on getting USC listed as an innovation hub (which would allow us to apply for a great amount of federal \$); all SC graduating seniors in the top 10% of their class (with certain exceptions) will be granted automatic acceptance to USC; the university has taken interest in targeting low-income SC counties for outreach (U Tennessee is doing the same); effort to reduce curriculum complexity (making it easier/more transparent for students to navigate degree requirements/completion) and part of this effort is also targeting curricular bottlenecks (those courses that have a high proportion of Ds and Fs, (e.g. certain STEM classes); effort to build a robust 1st year faculty onboarding process; Christian Anderson shared that the university will be celebrating the 150th anniversary of Reconstruction on October 7 at 2 pm with a ceremony on the horseshoe – if interested in contributing/participating, contact him.
