

### GRADUATE COUNCIL MINUTES

# March 25th, 2024

The Graduate Council met on Monday, March 25, 2024, at 2:00P.M. in Room #584, Close-Hipp Building.

- **1.** Call to Order and Approval of Agenda (Hassan Anderson, Chair) The meeting was called to order at 2:02p.m., and the Agenda was approved.

# **3. Report of the Chair** (Hassan Anderson)

Mr. Anderson shared that many students in his department have reported the feeling of being overwhelmed. He suggested that it may be beneficial for faculty to explore the extent to which students in other programs are experiencing similar feelings. Discussion followed where there seemed to be some consensus of other students expressing similar concerns.

Mr. Anderson also shared that he had attended a recent faculty meeting regarding graduate comprehensive exams where there was a general sense that exams need to be more comprehensive and rigorous. Discussion revealed that there may be a need for more consensus within the faculty for what is expected and clearer communication to students so that they might better understand what is expected of them. He asked the members of the Graduate Council if their departments used a rubric or

if they used the pass/fail option grading scale. This topic led to an extensive discussion. Dr. LaTrice Ratcliff-Small from the Office of Institutional Research, Assessment, and Analytics offered her assistance in working with academic assessment liaisons in each college and departments in defining rubrics and determining how to move forward in this effort. # 4. Report of the Dean of the Graduate School (Ann Vail)

Dean Vail reported that Student Health Services just hired a new consultant for graduate students. Her name is Nikki Buie, and she can assist you in strategizing and setting up resources/referrals to help educate your young new faculty and established faculty members as well. The attached Fact Sheet for Foreign Credential Evaluations shows the two vendors that the Graduate School has been reviewing for the implementation of evaluating international transcripts. They are World Education Services (WES) and Education Perspectives. Unless something odd happens, WES is the company that we will go with since they offer a broader and more comprehensive service. Our main reason for doing is to avoid the likelihood of fraud and misrepresentation of credentials due to the sheer number of applications we have received. If a student has already engaged a different international transcript service, we are investigating the possibility of accepting it as an exception. We are still evaluating how that would be handled. This information was presented to some of the Graduate Directors and Associate and Assistant Deans last week, where some concerns were expressed.

The Graduate School is holding an informational TEAMS meeting for Graduate Council, Graduate Directors, Associate and Assistant Graduate Deans, and other interested parties on April 9th at 10 am. We anticipate that the number of international applications received will decline. For the use of an international transcript service to be effective, official international transcripts will be required at the point of application. Unofficial international transcripts will no longer be accepted.

We will be using the WES ICAP services, and the cost will be \$225.00, effective applications received September 1st and after. We have not made the final decision, but it will be made very soon. Departments who are heavily recruiting students can purchase a voucher to assist with this cost. One good thing about WES is that their credentials do not expire. Some of the smaller companies only hold credentials for five years. These are in perpetuity. Our undergraduate admissions office uses WES, and our athletes also use WES.

Dean Vail recognized Graduate Council Graduate Student Representative, Gaurav Harshe, for an article that he wrote for *The Daily Gamecock* that was published on March 19th. The article is entitled "Graduate Students Deserve Better". She will contact them to see if they will accept a response from her regarding her support for many of the issues that Gaurav noted.

The second bi-annual Graduate Student Needs Assessment was released on March 20th. Dr. Angelina Sylvain is providing the leadership on this. Please encourage students to complete the assessment. At present, 322 completed surveys have been received, but we need more! The issues that you bring up are really what we need to collect data about to present to the decision makers for better opportunities for our graduate students.

Dean Vail reminded everyone of the Graduate School Recognition of Excellence awards program will be held at 3pm in the Lexington Room, Columbia Metropolitan Convention Center, immediately following Discover USC on April 19<sup>th</sup>. We hope to see you there since many of you will already be there as reviewers for your students. Dr. Jean Ellis provides leadership and can answer any questions that you may have.

The Dissertation Writing Academy is a collaboration among The Graduate School, Libraries, and the Writing Center. It will be held on May  $6^{th} - 23 rd$ . The purpose of the Dissertation Writing Academy is to provide guidance, instruction, motivation, and support for completing your dissertation. The program is specifically designed to support graduate students in the final stages of writing their dissertation. Applications are now being accepted. Dr. Mitchell reported that Discover USC is coming up on April 19th, and they have more graduate students presenting this year than ever before. The total number is 228 presently. The increase in presenters means a greater need for reviewers. While reviewer registration technically closed on March 22nd, the registration portal will likely stay open through next week. Everyone is encouraged to register to review. Faculty can review presentations from any population (undergrad, grad, postdoc, etc.), and graduate students can review undergrad presentations. We also need staff to register to help with logistics on the day of the event.

The Student Success Center has hired an advisor for graduate students, and he will be located full-time in the Grad Hub.
