Off Scene / Follow-up _____

- Digital
 - Send preservation letters for phones, social media, email
 - Obtain consent and password or search warrant
- Social media
 - Obtain consent & passwords, if possible
 - Screen shot publicly visible information, looking for:
 - Profiles, accounts, apps
 - Victim and suspect together
 - Tattoos
 - Gang signs
 - Age
 - School
- Reports from prior police contact, noting presence of victim with suspect or presence of tools of coercion
 - o Investigative reports
 - o 911 calls
 - Traffic violations
- Statements
 - o Witnesses
 - Hotel guests
 - Hotel employees

- Family
- Friends
- ER staff
- o Suspect
 - Written or recorded
 - Miranda form
- Victim refer to local CAC for forensic interview
- DNA samples
- Medical records of victim from current & prior treatment related to trafficking
- Search warrants
 - o Rental car company
 - o Hotel
 - Registration information
 - Video cameras
 - o Bank records
 - o Cell site information
 - o GPS date from vehicles
 - o Social media
