### Services Provided:

MH Community Mental Health Centers provide a wide array of intensive mental health services to children, adolescents, adults, and families with severe symptoms of mental illness, substance abuse (dual diagnosis) and/or emotional distress who are residents of South Carolina. Most services are provided by board certified psychiatrists and licensed clinical professionals.

Most DMH Community Mental Health Centers provide the following services:
